There are 19 Election Wards of this Corporation. Each Ward Consist 4 seats of Councillor Out of them 50 % of seats are reserved for Female. Thus 38 seats out of 76 total seats are reserved for Female candidates. Seats for Scheduled cast & Tribes as - well - as other backward class candidates are also reserved as per the Population Figure of 2011 Census.
